CASTROL TIMPSON RALLY Additional Supplementary

1. The Wolverhampton & South Staffs. Car Club Ltd. will promote a National British Rally on Saturday, 11th November, 1972, sponsored by Castrol Ltd. and William Timpson Ltd.

2.JURISDICTION. The event will be governed by the General Competition Rules, Standing Supplementary Regulations of the R.A.C., incorporating the provisions of the International Sporting Code of the F.I.A., these A.S.R.'s and any written instructions the promoting club may issue for the event.

3.PERMIT—AUTHORISATION. R.A.C. Permit No. 0E9360 has been issued. M.O.T. Authorisation Number is to be announced.

4.ELIGIBILITY. The event is open to all competitors holding an R.A.C. licence valid for the event. Navigators may hold a "Non-Drivers" licence. Intending competitors are reminded that where an entry is made in the name of a commercial firm or sponsor, that firm or sponsor must hold an Entrant's licence available from the R.A.C. and that this licence must be produced when other licences are examined.

5.START AND FINISH. The event will start from Carmarthen and finish at Shrewsbury. Total mileage will be 300 miles on public and private roads and there will be a compulsory halt after about 120 miles. Cars will start at one minute intervals. The event will contain several special stages on private property with a mileage of at least 60 miles. These stages, which will be timed to an accuracy of less than one minute, will be timed by R.A.C. approved timekeepers.

6.ROUTE. The route will be defined by six figure map references. Maps Nos. 116, 117, 118, 127, 128, 129, 139, and 140 will be required.

7.7.CLASSES The event will consist of four classes, as follows:

Class 1: All groups up to 1,000 cc.
Class 2: All groups 1,001 to 1,300 cc.

Class 3: All groups 1,301 to 2,000 cc.

Class 4: All groups 2,000 cc. and over.

8. AWARDS. Awards will be presented as follows:

GENERAL CLASSIFICATION

1st Driver: £150 and the Timpson Trophy to be held for 11 months.

1st Navigator: Castrol Cup and replica.

2nd Driver: £75 3rd Driver: £50 4th Driver: £40 5th Driver: £35 6th Driver: £30 £25 7th Driver: 8th Driver: £20 9th Driver: £15 10th Driver: £10

CLASS AWARDS

1st-£8, 2nd-£5, 3rd-£3 in each class.

OTHER AWARDS

To the best performance by an all W.& S.S.C.C. crew—£10, with the S. W. Fletcher Trophy for the driver and the Ron Moore Trophy for the navigator. Best Lady Driver—£10.

In addition there will be cash awards to those drivers who clean the stage without penalty on at least six nominated stages. Only those classified as finishers will be eligible for these awards. Details of the stages and of the value of the stage awards will be given in the Final Instructions. Where more than one driver beats the target time for the stage the value of the award will be dived equally among them. Winners of General Classification awards will not be eligible for class awards. No driver may win more than two cash awards for cleaning the nominated stages.

9.ENTRIES. The maximum entry for the event is 180. The organisers reserve the right to cancel the event if less than 100 entries are received. The entry list will open with the publication of these A.S.R.'s and closes finally (GCR 75) on November 6th. All entries must be made on the official form and be sent to Miss D. - 11. RESULTS. Provisional results will be published as soon as possible after the event. Protests must be made in accordance with S.S.R. P.46 (a).
- 12. INSTRUCTIONS. One hour before their starting time entrants will be supplied with a road book and route cards. Details of special stages will be contained in the road book. These documents will provide all information necessary to enable competitors to comply with S.S.R. S.35.

S.67 Ties will be decided by reference to times on the first special stage and if this does not resolve the tie, by reference to time on the second special stage, and so on.

14. SCRUTINEERING AND SIGNING ON. Details of scrutineering will be given in the final instructions but will take place between 7 pm. and 10 pm. on Friday, 10th November, and from 7 am. on Saturday, 11th November. At scrutineering vehicles will be examined for compliance with tyre and vehicle safety regulations and requirements. Cars must be fitted with a substantial roll cage and carry a fire extinguisher of at least 1 kg capacity. The attention of competitors is drawn to R.A.C. Vehicle Regulation DD1 (d). Crash helmets will also be examined at scrutineering and must comply with BSI 1869 or 2495. Competitors must report for signing on and scrutineering at least one hour before their scheduled start time

otherwise they will be deemed to have retired and their number wilt be allocated to the first available reserve.

16. IDENTIFICATION. Competitors will be supplied with rally plates to be affixed to the front and rear of the car. In addition competitors must display regulation sized numbers, which are in contrast to their background, on both sides of the car. Competitors may be required to carry advertising decals issued by the organisers on behalf of the sponsors.

17.ORDER OF STARTING. This will be at the organisers discretion, based upon competitors' previous results as stated on the entry form.18.

18.CONTROLS. There will be two types of control besides those at the start and finish of special stages. These will be Main Time Controls and Passage Controls. At Main Time Controls 30 minutes penalty-free lateness is allowed. Competitors will not be allowed to book out before their due time of departure. Secret checks may be established in accordance with S.S.R. S.34.

19.SPECIAL STAGES. At the start of special stages, cars will be sent off at one minute intervals. A countdown will be given. A flying finish will be used at the end of special stages. Timing will be to ,the second by split-action chronometers. It is the responsibility of a competitors see that times entered on his time card are correct. Immediately on arrival the start of each special stage competitors will be issued with an arrival time. This tithe will be used to assess penalties in accordance with A.S.R. 13 (S.65(v)) and also to calculate delay allowance. Delay allowance will be equal to the difference between the arrival time and the special stage start time where this timed difference exceeds five minutes.

20.SERVICING. Due to the increasing problem of obstruction caused by spectators and some service crews, certain areas will be deemed "No Service areas". Servicing is defined as work being carried out on the car by any person other than the crew, or the use of any parts or tools not carried in the competing car. There will be special areas at strategic points, defined as Service Areas and some of these will only be accessible to competitors and to service cars bearing a service plate. Service packs containing details of all service areas will be on sale at the start, price £1, and will be available from the Entries Secretary during the week prior to the event, price £1.25.

21.NOISE CONTROLS will be manned by Judges of Fact who will have the authority to exclude on first or subsequent report any competitor considered to be making an excessive noise.

22.INSURANCE. Competitors' attention is drawn to the insurance arrangements as offered by the R.A.C.'s Brokers, C. T. Bowring and Muir Beddall (Home) Ltd., which give, subject to an acceptable proposal, third party cover for £4.50 (Passenger Liability excluded). Entrants wishing to avail themselves of this offer must apply, with air entry, for a proposal form and should note that this must be returned fully completed to the Secretary of the Meeting not less than 14 days before the event Drivers who have already completed a proposal form should quote the reference number shown on their letter of acceptance, which must be produced to the club official when paying the premium, before the event takes place. Confirmation of cover, subject to the payment of premium, which must be paid before the start, will be indicated with final instructions to individual competitors. IT IS VITAL THAT COMPETITORS WISHING TO EFFECT THIS FORM OF INSURANCE COMPLY STRICTLY WITH THE TIMETABLE INDICATED.
