#### Article 7 Entry Fees - Insurance

7. The entry fee includes the insurance premium to insure the competitors and other parties as necessary against all third party risks whilst taking part in such parts of the rally on private lands or roads.

The indemnity provided under this special insurance is £5,000,000 (five million pounds sterling) covering any one incident or occurrence; except on Forestry Commission property where the indemnity is £15,000,000 (fifteen million pounds sterling), covering any one incident or occurrence.

This cover will come in to effect at the start of the rally and will cease at the end of the event or at the moment of retirement, exclusion or disqualification.

#### Article 11 - Starting Order - Plates - Numbers.

1. Exceptionally - The order of the start shall take into account the Series of the Driver, and may be changed to accommodate this.

#### Article 15 - Start

A list of competitors start times will be displayed on the official notice board from 21.00 hrs 20 October.

3. There will be NO controls nominated by the Organisers under this paragraph.

##### C Exclusion From The Event

1. The whole length of the Rally will be considered as one leg or section. (i.e. There will only be one period of 30 minutes total lateness throughout the Rally, 20 minutes of which will be penalty free)

Control TC11a will be the designated control referred to in Article 17.C.1 after the finish of the last stage. Hence for road section RS:11, to TC11b there will be no penalty free lateness. Competitors in this road section will be penalised for lateness at 10 seconds per minute over target arrival time at TC11b. The maximum lateness on this road section will be 15 minutes

#### Article 18 - Regrouping Controls

There will be no regrouping controls.

#### Article 21 - Scrutineering Before The Start And During The Event

Competition vehicles should, on arrival at Telford, proceed to 'The Exhibition Car Park' where 'trade' vehicles and the noise check will be situated. (see map)

The noise check will operate from 13.45 to 19.45 20 October only. A scrutineering card will be issued at the noise check.

It is strongly advised by the Police that trailers are not left in this car park for the duration of the Event as security cannot be guaranteed. There is insufficient room at the Rally Headquarters Hotel to accommodate trailers. Please seek advice at the Help Desk if this presents problems.

Cars should then move to Scrutineering.

Scrutineering is being held at The Central Fire Station, Stafford Park, Telford (see map) between 14.00 and 20.00 20 October only.

N.B. This is a change from the venue in the Regulations.

Competitors should report at the preferred scrutineering time they have indicated on their entry form. However crews should note that a large part of the entry has requested a scrutineering time of 16.45hrs and later. To avoid the inevitable queue the Organisers suggest that cars are presented for scrutiny before this time.

Documentation will take place in the Ironbridge Suite of The Telford Moat House Hotel between 14.00 and 21.00 hrs 20 October only. A completed scrutineering card the necessary licences, documents, other requested information and the presence of both crew members will be required before a start card can be issued.
