Add: S66 (xvi) Taking more than 10 Minutes between leaving the Scrutineering/Noise Check Area and reporting to parc ferme -Exclusion.

Modify: S66 (xiv) Possession of Pace Notes or refusing to allow search for same - Exclusion,

Add: S66 (xvii) Commencing Special Stage in advance of Start Flag being raised in accordance with ASR.18 - 1 minute.

### 13 SCRUTINEERING AND SIGNING ON

Details of Scrutineering and signing on are as follows:-

Scrutineering will also be carried out on Saturday morning from 06.30 hrs. This will be done by appointment only, made with the Secretary of the Meeting.

WINDSOR EVANS (Secretary of the Meeting) will be available from Friday morning onwards at Rally Headquarters (The Belle Vue Royal Hotel), Aberystwyth 7558.

On arriving at the Start Area competitors will first report to the noise check, followed by scrutineering and will then proceed to the Main Car Park where cars will be placed in parc ferme. Competitors will then proceed to signing on at Rally Headquarters (The Belle Vue Royal Hotel). The Start Card will be issued at noise check and must be produced at each stage of the proceedings and when fully completed will be exchanged, at signing on, for a

Road Book. 10 minutes are allowed between leaving the Scrutineering/Noise Check Area and reporting at parc ferme (see final instructions Addition to ASR12). Competitors attention is drawn to the maximum permitted noise level which is 84 db A. Competitors will be required to produce proof of insurance cover at signing on.

Ruthin Rally Numbers will sell regulation six door numbers in the Noise Check Area during Scrutineering periods.
